### Data Protection

Personal data held by The Haberdashers' Aske's Boys' School is subject to General Data Protection Regulation and the Data Protection Act 2018. The archive material held by the school may contain personal data relating, in particular, to: staff and students; enquirers; researchers; academics and others. Access to this information - and all personal data within the Archive, or otherwise made available by The Haberdashers' Aske's Boys' School ("Personal Data") - is permitted subject to the following terms.

I agree to the following conditions:

- I will ensure that my use (and any use permitted by me or on my behalf) of any Personal Data complies with the Data Protection Act 2018.
- I will use Personal Data contained in the Archive only for the purposes of my research, detailed below.

- In particular, I will maintain the privacy of ex-staff and ex-pupils, and will not disclose the identity of any living person whose Personal Data is made available to me by The Haberdashers' Aske's Boys' School without the consent of the relevant person and The Haberdashers' Aske's Boys' School.
- I will not directly contact any Data Subject, unless permitted to do so by The Haberdashers' Aske's Boys' School. Any contact will be made via The Haberdashers' Aske's Boys' School, at The Haberdashers' Aske's Boys Schools' discretion.
- I will ensure that any Personal Data obtained by me from the Archive is kept secure, and that it is securely disposed of when no longer required for the purposes of my research.
- I will comply with any additional restrictions or guidelines in relation to specific Personal Data or types of Personal Data which may be notified to me by The Haberdashers' Aske's Boys' School from time to time.
